

### **Dimensions of Modules and Racks**



NOTE: A normally closed relay contact rated at 220 Vac, 6A / 30 Vdc, 5A is available on terminals 1 and 2 of the power terminal strip. This contact set may be used to signal input power OFF, or a power supply failure. The relay will de-energize when input power drops below 8 Vdc.
